KONKOLA COPPER MINE (KCM) HAS THE ANTICIPATED

A Consortium of Civil Society Organizations championing the revamping of the mining sector says the recent unlocking of Konkola Copper Mine (KCM) under Vedanta Resources has started yielding the anticipated economic benefits.

Consortium Chairperson Samuel Banda. says this is evidenced by the Commissioning of an ambulance at Nchanga South Hospital by Vedanta Resources, which marks a significant development.

Mr. Banda, who

is also Advocates for National Development and Democracy (ANDD) Executive Director, notes that suppliers and contractors who had previously become inactive are now resuming operations, while over 1, 600 youths whose employment contracts were terminated have been recalled.

He further observes that in addition to increasing employees' salaries by 20 percent, providing a one-time payment of K2, 500 to KCM workers, and settling US\$250 million in payments to KCM contractors and suppliers, the investor has also begun to fulfill its Corporate Social

102 MEDICAL PRODUCTS SAFE FOR DISTRIBUTION AND SUBSEQUENT CONSUMPTION

Chasefu TowZambia Medicines and Medical Supplies Agency (ZAMMSA) says 102 medical products from the containers that were marooned at a private depot in Makeni, have been found to be compliant, safe for distribution and subsequent consumption by the public.

Agency Senior Manager-Corporate Communications, Bradley Chingobe says the results follow the procedural submission of samples to the Zambia Medicines Regulatory Authority (ZAMRA) for quality assurance tests.

Mr. Chingobe states that ZAMMSA has since received Certificate of Analysis results for the 102 products that have so far been tested by ZAMRA, and the Agency has started distributing the commodities to Health facilities across the country.

He adds that testing of the remaining products is actively ongoing by ZAMRA and the public will be informed once the results have been made available, further expressing happiness that the commodities tested so far meet the safety and efficacy standards.

About 61 containers of assorted medical supplies were marooned at the J&J depot in Makeni, pending the payment of storage charges by ZAMMSA. The consignment is part of the Government-to-Government bulk procurement of Medicines and Medical Supplies at a cost of US\$24 million from the Arab Republic of Egypt.

GOVERNMENT 'S NEGLECT OF LOCAL ENTREPRENEURS. growth and innovation to the second of the second of

Entrepreneurship is widely recognized as a crucial driver of economic development, employment creation, and innovation. Around the globe, governments are actively investing in policies and incentives to promote local entrepreneurship as a means of fostering sustainable growth.

Unfortunately, in Zambia, the reality is starkly different. Instead of nurturing and promoting local businesses, Zambia appears to have systematically erected barriers that stifle local entrepreneurial efforts while prioritizing foreign interests.

The government's failure to create an enabling environment for local businesses is not only a disservice to Zambians but also a significant missed opportunity for economic progress.

One of the most glaring issues is the deeply entrenched politicization of business opportunities. In Zambia, it often seems that political connections are more important than qualifications, experience, or innovative ideas.

Aspiring local entrepreneurs, no matter how skilled or knowledgeable, find themselves sidelined if they lack the political connections necessary to access opportunities.

This politicization effectively turns entrepreneurship into a patronage system where only the well-connected can thrive. This approach alienates the majority of the population and stifles the growth of new ideas that could diversify and strengthen the Zambian economy.

Moreover, access to government contracts and business opportunities in Zambia often feels like an exclusive club. The system is rigged to favor those with political influence or connections. sidelining small businesses and local entrepreneurs who desperately need government support to grow and sustain their ventures.

This bias not only discourages aspiring entrepreneurs but also creates a business landscape dominated by a few politically connected individuals.

This perpetuates inequality and limits the potential for broad-based economic growth.

The Zambian government's preferential treatment of foreign businesses further exacerbates the problem. The establishment of Multi-Facility Economic Zones (MFEZs), for instance, was a positive step aimed at spurring investment and development.

However, it has largely benefited foreign investors, leaving local entrepreneurs out in the cold. While foreign businesses enjoy tax exemptions, access to services like water and electricity, and a variety of incentives, local businesses struggle with prohibitive costs and lack of support.

The barriers to entry for local businesses in these economic zones are insurmountable for many. Requirements are stringent and geared toward well-established, resource-rich foreign firms rather than local startups and small businesses.

By favoring foreign investors at the expense of local entrepreneurs, the government sends a clear message: Zambia's business environment is more welcoming to outsiders than to its own citizens.

For the average Zambian entrepreneur, the cost of doing business is astronomical.
Entrepreneurs must navigate a labyrinth of expenses, from hefty registration fees to exorbitant taxes, high utility bills, and multiple regulatory costs.

A small television station, for example, must contend with paying K20,000 annually to the Independent Broadcasting Authority (IBA), between K4,000 to K8,000 monthly to TopStar, K10,000 for internet services, and K15,000 in operator licenses, among other fees.

These expenses, coupled with statutory obligations like NAPSA contributions, place an enormous burden on small and medium-sized enterprises (SMEs).

For most local entrepreneurs, these costs are unsustainable. Instead of focusing on

growth and innovation, businesses spend the majority of their resources simply staying afloat.

It is no surprise, then, that many local entrepreneurs either shut down their businesses or turn to employment in search of more stable income.

The existence of a Ministry for Small and Medium Enterprises has done little to alleviate these struggles.

Despite the promises of support, there are few tangible benefits that local entrepreneurs can point to.

The rhetoric of reducing the cost of doing business and eliminating bureaucratic obstacles has not been matched by meaningful action.

Policies like the 20% local contractor requirement have proven ineffective, as local contractors continue to be bypassed in favor of foreign entities.

Zambia urgently needs a deliberate, comprehensive approach to promoting local entrepreneurship.

The government must go beyond mere lip service and take concrete steps to create a business environment that supports local innovation and growth.

A good starting point would be to streamline the various business costs through a unified egovernment system, making it easier for SMEs to manage their regulatory obligations.

Additionally, simplifying the process of registering and operating a business, coupled with targeted tax incentives for local startups, would significantly reduce the financial burden on entrepreneurs.

More importantly, the government must address the issue of political gatekeeping. Business opportunities should be open to all, not just those with the right political connections.

Transparent, merit-based systems should be implemented to ensure that entrepreneurs are judged on their qualifications, experience, and business acumen, rather than their political affiliations.

The government's focus on foreign investment

should not come at the expense of local businesses. While foreign investment is crucial for economic growth, it must be balanced with deliberate efforts to support local entrepreneurs.

Expanding access to the Multi-Facility Economic Zones for local businesses, offering them similar incentives to those given to foreign investors, and providing access to vital infrastructure and services are necessary steps toward leveling the playing field.

Entrepreneurship is vital to the future of Zambia's economy. By neglecting local entrepreneurs, the government is undermining the country's potential for homegrown innovation, job creation, and sustainable development.

The Zambian government must commit to fostering a business environment where local entrepreneurs can thrive. This means reducing the cost of doing business, eliminating unnecessary bureaucratic hurdles, and ensuring that political connections do not determine access to opportunities.

Zambia cannot afford to lose its entrepreneurial spirit. The time for action is now—local entrepreneurs need real support, not just promises. Without deliberate measures to promote local businesses, Zambia risks falling behind in an increasingly competitive global economy, leaving its citizens without the opportunities they deserve.

GOVERNMENT 'S NEGLECT OF LOCAL ENTREPRENEURS.

Reporting Framework, as this He notes that these frameworks will provide a robust foundation for setting benchmarks, aligning with national and international goals, and promoting transparency and accountability, as well as bolster investor confidence, thereby positioning Zambia as a leader in sustainable business practices.

And ZICA President Yande Mwenye says the Institute's adoption of IFRS S1 and S2 in November 2023, was a watershed moment for financial reporting in Zambia, therefore the workshop marks an important step forward in the country's commitment to enhancing financial transparency and Sustainability Reporting.



TIKTOK CASE CONTINUES



TikTok will start making its case on Monday against a law that will see it banned in the US unless Chinese owner ByteDance sells the social media app within nine months.

The measure - signed into law by President Biden in April - has been prompted by concerns that US users' data is vulnerable to exploitation by China's government.

TikTok and ByteDance have always denied links to the Chinese authorities and have described the law an "extraordinary intrusion on free speech rights."

free speech rights."
The firm, which claims to have more than 170 million US users, will make its arguments before a three-judge panel at an appeals court in Washington DC.

Company representatives will be joined by eight TikTok creators, including a Texas rancher and a Tennessee baker, who say they rely on the platform to market their products and make a living. Lawyers from the Department of Justice (DoJ) will then proceed to lay out their case. In addition to data concerns, DoJ officials and lawmakers

have expressed alarm at the prospect of TikTok being used by the Chinese government to spread propaganda to Americans. However, advocates of America's powerful free speech rights, enshrined in the First Amendment of the US Constitution, say upholding the divest-or-ban law would be a gift to authoritarian regimes everywhere.

"We shouldn't be surprised if repressive governments the world over cite this precedent to justify new restrictions on their own citizens' right to access

information, ideas, and media from abroad," said Xiangnong Wang, a staff attorney at Columbia University's Knight First Amendment Institute. It has filed an amicus brief legal documents submitted by someone not a party to the case but with an interest in it, offering information or expertise, usually with the hope of influencing the outcome. Mr Wang also criticised lawmakers for being vague about the specific national security threats that they say TikTok poses.

JUNTA-LED WEST AFRICAN STATES TO LAUNCH NEW PASSPORT

Three West African countries run by military juntas will be launching a new biometric passports "in the coming days" as part of their withdrawal from the wider regional bloc Ecowas.

Mali, Burkina Faso and Niger, whose military leaders took over power in series of coups between 2020 and 2023. announced their plan to leave the bloc in January.

Following the coups, West African countries sanctioned the juntas, aiming to push them to quickly restore civilian rule.

But the three nations that now form the Alliance of Sahel States have so far resisted the calls, opting to cement their alliance.

"In the coming days, a new biometric passport of the [alliance] will be put into circulation with the aim of harmonising travel documents in our common area," Malian junta leader Col Assimi Goïta said in a televised address on late on Sunday.


