

"This growth also attracted upstream investment and expansion in the supply of animal feed for both local and export markets as well as value addition," he said.

### **GOVERNMENT OWING FARMERS K1.5 BILLION FOR MAIZE SUPPLIED TO THE FRA**

Minister of Agriculture has disclosed that Government is owing farmers K1.5 billion for 465, 000 metric tonnes who supplied their maize supplied to the of white maize Food Reserve Agency (FRA) during the 2024 crop marketing season.

Reuben Mtolo told Parliament during the question for oral answer session that in Chama district of Eastern province, FRA has bought over 2, 237.3 metric tonnes of non-GMO white maize valued at K14.7 million, out of which K8.5 million has been paid to the farmers, with a balance of K6 million yet to be

cleared. Mr. Mtolo reveals that FRA has also purchased over countrywide as at 22nd the farmers will be September 2024, costing more than K3 billion, out of which K2 billion has been paid, representing 64 percent performance.

He has assured that K500 million will be released next week and the other week in order to ensure that all the farmers are cleared. Mr. Mtolo was responding to Chama North Member of Parliament Yotam Mtayachalo, who

### MUSOKOTWANE ANNOUNCES K217 BILLION BUDGET FOR 2025, REPRESENTING 260% OF GDP



Government has proposed to spend K217 billion in 2025, representing 26 percent of the country's Gross Domestic Product (GDP).

Presenting the 2025
National Budget in
the National
Assembly today, Dr.
Situmbeko
Musokotwane says of
this amount, K174
billion will be
financed by domestic
revenue, K8.2 billion
by grants from
cooperating partners

and K34.7 billion through borrowing.

Dr. Musokotwane has also announced an increase in Constituency Development Fund (CDF) budget to K5.6 billion in 2025 from K4.8 billion, with each constituency getting K36.1 million from K30.5 million.

He also says Government proposes to increase allocation for the strategic food reserves to K2.4 billion in 2025 from K1.7 billion in 2024, in order to ensure food security, while K48.7 billion has been allocated towards Economic Affairs to stimulate economic activities.

Musokotwane discloses that government will recruit 2, 000 teachers in 2025, in addition to the 4, 200 teachers that will be employed this year, while the health sector will also hire 2, 000 health personnel under next year's

### ZCSA ENHANCES SCOPE OF TESTING, INSPECTIONS TO COVER AFLATOXINS

Zambia Compulsory Standards Agency (ZCSA) says it has enhanced the scope of testing and inspections to cover aflatoxins on a continuous basis for both raw materials and finished products.

Speaking when he paid a courtesy call on
Copperbelt Permanent
Secretary Augustine
Kasongo, Agency Board
Chairperson, Ian Besa said this follows the recent detection of high levels of aflatoxin contamination in some batches of mealie meal.

Mr. Besa stated that the Agency has also enhanced public education interventions to mitigate misinformation on aflatoxin contamination and ultimately ensure that only safe products are available on the market.

"ZCSA, working with other state institutions, has implemented adequate measures to safeguard the health and safety of consumers following the detection of elevated aflatoxin levels in some batches of mealie meal and dog food. Noncompliant bags of mealie meal were seized, withdrawn from the market and destroyed for the purpose of protecting consumers."

"The Agency wishes to emphasize that the issue of non-compliance on the levels of aflatoxins was specific to the identified mealie meal batches referred to above," Mr. Besa stated.

He added that millers are now required to have a standing monitoring program for aflatoxins internally on both raw materials and finished products, and that records for this activity should be provided on request.

Mr. Besa reiterated that all mealie meal brands currently on the market have been certified safe including those that had the affected batches withdrawn from the market and destroyed.

And Mr. Besa has urged farmers to buy fertilizer from recognised, regulated and reputable outlets or distributors to be assured of a good crop yield, as the 2024/2025 farming season approaches.

He encouraged farmers to be quality conscious and ensure that they have adequate information on the fertilizer they are buying or using.

"Consumers must also report to ZCSA any suspicious fertilizer, including acts such as illegal mixing of fertilizer with other materials or chemicals by unscrupulous individuals."

"This will help them to avoid buying unsafe or inappropriate fertilizer

that may cause poor crop yields or pose a risk to their health and safety," he added.

Meanwhile, Copperbel
Permanent Secretary
Augustine Kasongo
encouraged ZCSA to
carryout more
sensitization programmes
on its mandate through
radio programs, in order
for people to know and
understand the Agency's
mandate.

"If people have that information especially through radio programs in vernacular, and you speak to the issue of fertilizer, so that people must know that if they are scammed they have got where to report."

"You have rightly said that you have representation in all the districts in the country so if only you could up your game in terms of selling the Agency to the public, I think that would do a lot of justice to the citizens of this country. A lot of our people do not know where to report," Mr. Kasongo stated.

ZCSA regulates 61 products which are covered by compulsory standards and these include food products, beverages, chemical products, fertilizer, fuel, cement, household electrical appliances and used textile products, among others.

### FSSMAZ URGES GOVERNMENT TO SIMPLIFY MINING LICENSE PROCESS

The Federation of Small Scale Mining Associations of Zambia (FSSMAZ) is calling on the government to streamline the process of obtaining mining licenses to combat illegal mining in the country.

Speaking in an interview with Money Daily, FSSMAZ
President Joseph
Mwansa highlighted that the current fee of 80 thousand Kwacha for a license from the Zambia
Environmental
Management Agency

significant barrier for ordinary Zambians. "The costs associated with obtaining a license from ZEMA are high and too expensive for ordinary Zambians," Mwansa explained.

Mwansa has suggested that the government should create a supportive framework for the private sector and equip cooperatives with detection equipment capable of locating gold deposits up to 20 meters underground. He says this will enable local miners to

establish a market for their gold within the country.

"Once cooperatives have the right tools, they can create a market system for local production," Mwansa said. "Currently, 95 percent of the gold produced in Zambia is smuggled out of the country." Meanwhile, an economist Kelvin Chisanga said that Zambia remains heavily reliant on copper despite its vast gold reserves. He has emphasized the need for effective policies to diversify

the mining sector.

"Gold is a strategic reserve commodity, and it is critical for our economic stability," Chisanga said.

### TOP GOVT OFFICIALS EMBROILED IN **DUBIOUS K1.5 TRILLION FUEL, FERTILIZER**

A shocking investigation has uncovered a web of corruption involving high-ranking government officials in Malawi.

Secretary to the President and Cabinet Colleen Zamba has been implicated in negotiating lucrative fuel and fertilizer deals without proper procurement procedures.

According to The Investigator Magazine, the deals, worth K1.5 trillion, involve the supply of 250,000 metric tons of fuel and 600,000

metric tons of fertilizer. Zamba allegedly singlehandedly negotiated a Memorandum of Understanding (MOU) with a dubious Dubai-based company, Office of H.H. Sheikh Ahmed Al-Qassimi.

its letter to Hara on 4 September 2024, claims that its bankers have already paid for the 40,000 mt tonnes of fuel through emergency arrangements. The word "emergency" is used in the deal to justify the cutting of all procurement corners.

Further investigation by The Investigator issued invoices worth suspicious

transactions involving OptCoin Malawi, a company registered in July 2023, and Option Malawi, a private business account at Standard Bank. Payments for OptCoin Malawi were allegedly remitted into Option Malawi's account, controlled by a Zamba associate in South Africa.

Several high-ranking officials implicated in the syndicate include Zamba, Secretary to the President and Cabinet; Hara, Transport Minister; Sam Kawale, Agriculture Minister and Chikunkhuzeni, SFFRFM CEO.

### FACEBOOK PARENT COMPANY FINED **€91M OVER PASSWORD STORAGE**

Facebook parent company Meta has been fined €91m (£75m) by the Irish Data Protection Commission (DPC) following an investigation into the storage of passwords.

An inquiry was launched in April 2019 after Meta notified the DPC that it had inadvertently stored certain passwords of social media users on its internal systems without encryption.

The DPC submitted a draft decision to other European data watchdogs
