K4.4 MILLION LIBALA WATER Works Network Extension Project 80% complete

Lusaka Water and Sanitation Company (LWSC) says the K4.4 million Libala Water Works Network Extension project has reached 80 percent completion level.

Company Public Relations Manager, Ruth Mulenga Mukuwa said the project, which involves the construction of a 4kilometer water supply services, commenced in November 2023 and is scheduled for completion by December 2024.

Ms. Mulenga states that the project, is fully funded by the utility company and it is aimed at improving

"As of 30th September 2024, the project achieved 80% completion, having met key milestones such as mobilization, excavations, and the laying and jointing of pipes. The next phase will involve energizing the network and installing household connections once the necessary fittings are installed," Ms. Mulenga stated.

She added that the remaining works will include individual household connections, which will begin once the water network is fully energized with water.

Today, two striking events unfolded on the African political landscape that carry invaluable lessons for political leaders and citizens alike. In Botswana, outgoing President Mokgweetsi Masisi conceded defeat to the opposition, marking a historic end to the Botswana Democratic Party's (BDP) 58-year reign.

Across the border in Zambia, former Lusaka Province Minister Bowman Lusambo, once feared and revered, was apprehended after being found hiding in his home's ceiling. These developments expose a stark reality for politicians: political power is fleeting, and real authority lies with the people.

President Masisi's concession in Botswana is a powerful symbol of democracy in action. For nearly six decades, the BDP wielded unchallenged authority, its dominance entrenched so deeply that few could envision its fall.

But as with any monopoly on power, cracks inevitably form. Despite the loyalty once commanded by his party, Masisi faced a resounding defeat.

In conceding, he demonstrated that true leadership sometimes means stepping down gracefully—a stark contrast to leaders who cling to power at any cost. Masisi's defeat serves as a reminder to every political

Today, however, that power has dissolved, and his fall from grace has been swift. His arrest not only underscores the ephemerality of political influence but also illustrates his fall from grace has been also illustrates the perils of arrogance and abuse of authority. Lusambo's plight sends a clear message: when you misuse power, the consequences will eventually catch up with you.

These contrasting but complementary events in Botswana and Zambia underscore the essential truth that political power is, and should always be, temporary. For any leader, power is merely a loan from the people, granted

with trust and withdrawn with disillusionment when abused.

However, this truth is often obscured by the trappings of office. Many politicians start their journeys as humble aspirants, promising to serve with integrity and humility. Yet, upon gaining power, they shift—surrounded by sycophants, they become indifferent to the struggles of ordinary citizens and driven more by personal gain than public service.

arrogance, and the desire for control. Politicians who perpetuate a culture of cronyism and tolerate lawlessness among their supporters not only degrade their leadership but erode public trust.

By employing cadres to do their bidding, they abandon the principles of governance and instead create personal fiefdoms where loyalty is bought and dissent is suppressed. This kind of leadership is not

sustainable. The events in Botswana and Zambia today reveal that such abuse of power carries inevitable repercussions.

The lesson from today is clear: political leaders must embrace the temporality of their power and act as true servants of the people. The office they hold is a privilege, not a right, and their responsibility is to lead with humility and foresight. When they leave office—whether voluntarily or by mandate—their legacy should be one of progress, integrity, and respect for the people's will.

By heeding the examples of Masisi and Lusambo, leaders across Africa and beyond can avoid the pitfalls of power, building a future where politicians are remembered not for their wealth or power but for their service to the nation.

Let today serve as a reminder: no politician is invincible, and real power will always rest with the people. Those who use their influence to uplift others will be remembered with respect; those who exploit it for personal gain will find themselves alone, abandoned by the very people they sought to dominate.

SCCI OUTLINES BENEFITS OF PROPOSED AMENDMENT OF PLANT BREEDERS RIGHTS BILL

Seed Control and Certification Institute ((SCCI) says the proposed amendment of the Plant Breeders Rights (PBR) Act of 2007 is aimed at allowing farmers to access a diversity of crop varieties that respond to climate change. Institute Representative Dr. Richard Chanda said in 1976, African States recognized that Plant Breeders Rights can add value to agricultural productivity and Zambia came up with the new Act which has been running for several years, but the country wants to have it repealed and replaced so that it conforms to international standards. Speaking to Journalists on the sidelines of an advocacy meeting focusing on diverse and Climate-Resilient Food Systems in Zambia, organized by Civil Society for Poverty Reduction (CSPR), Dr.

Chanda noted that the country has had so many seed companies that have been doing breeding of so many varieties but with the current climate change, there is need to go an extra mile, and take advantage of the Plant Breeders Rights.

"The Plant Breeders Rights is being repealed and replaced and we have a Bill that we are consulting with stakeholders and farmers so that they can comment on it. Consultations have begun, however. we have noted that in some areas there have been reactions and so on, and what I want to appreciate is the cooperating partners who have realized that for farmers to fully participate in this Act, they need also to be brought on board," Dr. Chanda said. He emphasized that the

two-day advocacy meeting is aimed at taking the farmers through the proposed bill and explain its benefits and challenges that need to be addressed, as well as allow farmers to make their submission as consultations continue.

"So that is the purpose of the meeting to educate the farmers and cooperating partners that there's bill that they need to make comments to but before they do that is to make them run through, they read it and understand so their contribution is going to add value to what is already proposed." The request is upon the farmers here that now they have known what the Plant Breeders Right is, what is the intention of the Plant Breeders Right, which is to allow farmers to access a diversity of crop varieties that respond to climate change. The Plant

Breeders Rights is able to bring in another extra innovation," he stated.

Meanwhile, some farmers who were part of the meeting emphasized the need for stakeholders to ensure that the information is disseminate the information on Plant Breeders Rights to the farming community in a simplified language to make it easy for them to understand. Amendments to the Plant Breeders' Rights (PBR) Act (2007) to align with the International Union for the Protection of New Varieties of Plants (UPOV)1991 standards in order for Zambia to become a member.

The PBR Act is concerned with providing plant breeders with exclusive rights to varieties they develop, whilst limiting others' use rights to these varieties.

BBBc reports that despite being one of the world's wealthiest companies, that is


considerably more than the \$2 trillion Google is worth.

Dollar Dips After US Job Growth Slows Sharply In October – Reuters

The dollar erased early gains to trade lower against the euro on Friday after data sharply in October amid disruptions from hurricanes and strikes by aerospace factory workers. Nonfarm payrolls increased by 12,000 jobs last month after surging by a downwardly revised 223,000 in September, the Labor Statistics said on Friday. Economists polled by Reuters had forecast payrolls rising 113,000.

China's Zeekr Reports EV **Deliveries In October Nearly Doubled, Clocks Its Best** Monthly Numbers – CNBC

Chinese electric carmaker Zeekr said Thursday its deliveries surged showed US job growth slowed by 92% in October from a year ago, helping the company clock its best month at 25,049 vehicles. That beat the prior record of 21,333 deliveries in September, bringing Zeekr's total for the year to nearly 168,000. The company has reportedly said that it expects to deliver 230,000 cars in 2024. Labor Department's Bureau of With only two months left in the calendar year, that means Zeekr needs to deliver more than 31.000 cars in November and December each.

Nigeria introduces amnesty plan to get dollars stashed outside banks – Business Insider Africa

Nigeria has launched an amnesty program starting October 31, designed to bring foreign currency held outside the banking system back into circulation. This initiative aims to revive the struggling naira. Finance Minister Wale Edun stated on Thursday that individuals will not face tax audits, nor will the government seize their assets, and the program will remain open for nine months. "The scheme offers a secure, confidential channel for people to reintegrate their legitimate foreign currency funds, promoting stability and growth for our nation,". "There will be no penalty, there will be no taxes, and there will be no questions. They just meet the normal Know Your Customer criteria of banks and they have an opportunity to bring in those funds, make them safe, make them secure, and make them available through normal economic activity," he said.

The Football Association of Zambia's (FAZ) Player Status and Transfer Committee has thrown out former Kansanshi Dynamos coach Donewell Yobe's case against his former employers.

This is in a case in which Yobe reported Kansanshi Dynamos to the Player Status and Transfer Committee for unilaterally terminating his 24-month employment contract.

According to the Status Committee, Yobe's case lacks merit, as evidenced by the contract signed by both parties, as the coach failed to meet key

performance indicators to sustain his contract beyond the probation period.

Keeping the Solwezibased side in the Super League during the 2023-24 season was among the three key performance indicators assented to by both parties.

In another ruling, the committee has directed Mutondo Stars to pay Chisha Kampamba all outstanding dues in case the club defaulted on its financial obligations to the player for the months of March April, May, and June 2024.

The committee heard that Chisha signed a contract with Mutondo Stars FC for a duration of twenty-four (24) months, running from 1st November 2023 to 31st November 2025.

The committee has ruled that the player is free to move to any club after terminating the club for a just cause.
